Additional comments received;

Little Shawfield Churt Road, Farnham

I am concerned that this represents yet more increases in the volume of low flying, noisy a/c traffic funnelled directly overhead the 14,000 residents of Grayshott, Hindhead, Beacon Hill, Churt, Rushmoor, Tilford on the southern STAR into Farnborough. The noise is highly invasive in what used to be a quiet rural area. Increased buildings equals greater volumes and should be curtailed not increased.

Officer comment: As set out within the report, the proposal does not involve any change in the number of flights permitted by the operative planning permission (20/00871/REVPP).

• 6 The Sycamores, Farnborough,

[on the website] The applicant, under the heading 'Constraint Type' says the proposed terminal is 'Within Third Party Risk Area". But under the heading 'Status' it then says 'Ceased'.

Whilst PSZ areas have been reduced, the proposed terminal must fall within Rushmoor's unamended annual individual risk contours invoked in the Local Plan Policy Sp4.4; this policy being among those listed as material to the determination of this application. (See Richard Ward's confirmation that the contours can only be amended in support of an application to change the aircraft mix or permitted annual movement).

Therefore, in determining this planning application, the Planning Committee should recognise the need to maintain a clear distinction between PSZ and Local Plan policy, notwithstanding that in this case safety is a matter for the operator as the development falls entirely within the airport boundary.

Officer comment: The site is located outside of the PSZ and these comments are therefore not relevant to the determination of this application.
