DETERMINATION OF AN APPLICATION FOR THE REVIEW OF A PREMISES LICENCE EVEREST CASH & CARRY, 82 - 84 COVE ROAD, FARNBOROUGH, HAMPSHIRE, GU14 0EU

1.0 INTRODUCTION

- 1.1. This report concerns an application for the review of a premises licence made under section 51 of the Licensing Act 2003 (the 'Act'). The receipt of such an application invokes a statutory requirement to hold a hearing with Members to consider it.
- 1.2. The report provides details of, and background to the application, and should be read in conjunction with the council's licensing policy and Secretary of State's guidance. This, together with information obtained at the hearing should be used to determine the application.

2.0 BACKGROUND

2.1. On the 4th October 2017, a responsible authority, namely Hampshire County Council Trading Standards, submitted an application for the **review** of the premises licence held in respect of Everest Cash & Carry, 82 - 84 Cove Road, Farnborough, GU14 0EU. A copy of the review application together with its enclosures is given at **appendix A**. A map of the area showing the general location of the premises is given at **appendix B**.

2.2. Existing premises licence

- 2.3. The application requests the review of the premises licence number 17/00497/LAPREM, held in respect of the premises, initially granted on 30th September 2008, and subsequently transferred to Oasis Trading Impex Ltd. on 3rd October 2013. The licence was varied on 13th July 2017. A copy of the current premises licence is given at appendix C.
- 2.4. The licence is subject to a number of mandatory and transposed conditions. It authorises the retail sale of alcohol for consumption off the premises, between 7:00am and 21:00pm on any day.

3.0 ADMINISTRATION OF REVIEW APPLICATION

3.1. Advertising the review application

- 3.2. In submitting an application for review, it is the duty of the applicant to ensure that notice of the application is given to all responsible authorities and the licence holder to which it relates. It is also the duty of the licensing authority to advertise receipt of the application by way of enabling representations to be made by other parties.
- 3.3. I can confirm that the applicant and each responsible authority have received a copy of the review application and the licensing authority has advertised receipt of the application both at the premises and at the Council Offices in accordance with the requirements of the Act.

4.0 GROUNDS FOR REVIEW

4.1. The grounds for review of the premises licence are set out in Part 2 of the review application (see **appendix A**).

4.2. Relevance of grounds for review

- 4.3. By virtue of section 51(4) of the Act, the licensing authority may, at any time, reject any ground for review if it is satisfied that the ground is not relevant to one or more of the licensing objectives.
- 4.4. The grounds for review are considered to be relevant in this case, as the application has been made by a responsible authority and concerns the licensing objectives **the prevention of crime and disorder**, and **the protection of children from harm**.

5.0 REPRESENTATION(S)

5.1 Two representations have been received in respect of the application, from responsible authorities namely The Licensing Authority and Hampshire Constabulary. These are given as **Appendices D** & **E** respectively.

6.0 DATA PROTECTION ISSUES

6.1 In accordance with data protection requirements, any personal details, addresses, contact details and/or signatures submitted on any application, representation or other relevant document etc. have been redacted.

7.0 DETERMINATION

7.1. The Sub-Committee is asked to determine the application for review.

8.0 RELEVANT CONSIDERATIONS

8.1. Licensing objectives

- 8.2. In considering the application the licensing authority must have regard to the promotion of the licensing objectives. These are:
 - (a) the prevention of crime and disorder;
 - (b) ensuring public safety;
 - (c) the prevention of public nuisance; and
 - (d) the protection of children from harm.

8.3. Licensing policy & Secretary of States guidance

8.4. The licensing authority must also have regard to its statement of licensing policy and any guidance issued by the Secretary of State. Details of the parts of the policy and guidance that may be relevant to this application are given in **appendix F**.

8.5. Human rights

- 8.6. Members are reminded that in determining a review application the licence holder is entitled to a fair hearing, on merit and, any action(s), terms or conditions imposed must be both proportionate and necessary.
- 8.7. A premises licence is deemed to be a possession under Article 1(1) of the first protocol.

8.8. Appeals

8.9. The applicant for the review, the holder of the premises licence and/or any other party who made representations have a statutory right of appeal to the Magistrates' court within 21 days of being notified of the decision / outcome. The decision of the Sub-Committee has no effect until the appeal period has passed or until the appeal is disposed of.

9.0 OPTIONS

- 9.1. In determining this application the Sub-Committee must, having regard to the review application and any relevant representations, take any one or any combination of the following steps as it considers appropriate for the promotion of the licensing objectives, namely:
 - (a) to take no action;
 - (b) to issue an informal warning and/or recommend improvement(s);
 - (c) to modify the existing conditions of the licence**;
 - (d) to exclude a licensable activity from the scope of the licence**;
 - (e) to remove the designated premises supervisor;

- (f) to suspend the licence for a period not exceeding three months; and/or
- (g) to revoke the licence.

** for this purpose, the conditions of the licence are modified if any of them is altered, omitted or any new condition is added.

- 9.2. Where undertaking any of the steps in subparagraph (c) or (d) above, the Sub-Committee is reminded that there are mandatory conditions that must be included in a premises licence where applicable. These are detailed at **appendix G**.
- 9.3. Where the Sub-Committee considers the removal of the DPS, members are reminded that the holder of a premises licence may make an application to vary the premises licence to specify a new individual as DPS at any time. The premises licence holder can specify that this application take immediate effect until it is determined in accordance with the Act.

10.0 RECOMMENDATION(S)

- 10.1. The Sub-Committee is asked to determine the application having regard to -
 - (a) the contents of this report;
 - (b) any additional information obtained from the hearing;
 - (c) the Council's licensing policy;
 - (d) guidance issued by the Secretary of State; and
 - (e) the promotion of the licensing objectives.

28/04/17 – Hampshire Constabulary test purchase failure, alcohol was sold to an underage volunteer.

22/06/17 – Advice visit by Trading Standards Officer (TSO) Lawford, training records could not be produced; the refusals book was not being checked weekly.

23/08/17 –Trading Standards test purchase failure, alcohol was sold to a 16 year old female volunteer by a person who did not work at the shop. No entries had been made in the refusals book since TSO Lawford visited on 22/06/17.

We highlight paragraph 11.28 of the Secretary of State's Guidance issued under Section 182 of the Licensing Act 2003.

11.28 It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.

This store has been test purchased three times in six months and has failed each time. This is totally unacceptable and we believe is enough for the subcommittee to consider revoking the premise licence.

However, it's made worse by the total ineptitude of the premises licence holders to promote the licensing objectives. Despite visits and advice from Rushmoor BC Licensing Officers, the police licensing officer and TSO Lawford, staff selling alcohol have not received any training and have failed to enter refusals in the refusals book for large periods of time.

Matters were exacerbated when the store was test purchased by Trading Standards on 23 August 2017. A person who did not work at the shop went behind the shop counter and sold alcohol to a 16 year old female volunteer working with Trading Standards.

We believe it's proportionate and appropriate to revoke the premise licence.

Annex 1 – Mandatory conditions

- (1) No supply of alcohol may be made under the premises licence:-
 - (i) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (ii) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (3) (i) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (ii) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

Annex 2 – Conditions consistent with the Operating Schedule

- (1) No licensable activities shall be undertaken except during permitted hours.
- (2) All age-restricted products shall be located behind, immediately adjacent to or within direct, unhindered visual sightline of the main point of sale service counter where access to such products can be adequately supervised, monitored and where necessary, controlled by staff.
- (3) All staff / employees shall (before being permitted to make sales of alcohol) be given suitable and sufficient training in relation to the lawful sale of alcohol and the procedures adopted at the premises in respect of alcohol sales to a level commensurate with their role and responsibilities.
- (4) All equipment such as air conditioners, refrigeration units, condenser units etc. attached to or positioned outside the building shall be placed on suitable anti-vibration mounts, and fitted with suitable and sufficient sound proofing to prevent the equipment causing nuisance in neighbouring residential properties.
- (5) (i) A suitable noise complaints procedure must be established and in operation at the premises (e.g. all staff must be familiar with the complaints procedure and any complaint(s) made in respect of the premises, its customers, staff and/or the activities carried on there must be investigated and remedied as soon as, and, so far as is reasonably practicable to prevent public nuisance).
 - (ii) Suitable written records (e.g. the nature of any complaint(s), action(s) taken in response, the date(s) and time(s) when any complaint was made, together with the name of the person(s) who handled the complaint) must be kept and made available to officers of Rushmoor Borough Council on request.
 - (6) All lighting including external lighting and lights activated by sensors shall be correctly adjusted so that it only illuminates the surface(s) intended and do not unreasonably throw light onto neighbouring property.
 - (7) The area in the immediate vicinity of the premises shall be cleared of litter, including waste arising from smoking activities, on a regular basis and always at the close of business.
 - (8) All staff / employees at the premises shall be made aware of the conditions attached to this licence through a mechanism in writing.

- (9) (i) Anyone authorised to sell or supply alcohol at the premises shall request and ensure sight of suitable identification, for proof of age, of any person appearing to them to be under the age of 25 (twenty-five) and who is attempting to purchase alcohol.
 - (ii) For the purposes of thos confition, suitable identification is photo driving licence, passport, or any other photographic identification bearing the "PASS" loho and the persons date of birth.
 - (iii) Further to the above, anyone authorised to sell or supply alcohol at the premises shall be instructed that no sale of alcohol shall be made unless suitable identification, for proof of age, can be provided.
 - (iv) Suitable and sufficient warning signs shall be displayed in the premises providing information in respect of the above challenge 25 policy and request the suitable identification in connection thereof.
- (10) (i) Anyone authorised to sell alcohol at the premises shall (before being permitted to make sales of alcohol) be suitably trained in respect of the following matters to a level commensurate with their duties and responsibilities:-
 - (a) The refusal of the sale of alcohol to those who appear intoxicated and how to recognise them; and
 - (b) The appropriate precautions to prevent the sale of alcohol to persons under the age of 18.
 - (ii) Refresher training shall take place at least every 6 months.
 - (iii) written records of such training shall be produced, and be signed and dated by the member of staff receiving the training. They shall be kept on the premises to which they relate for a minimum of 2 years and be made available to the responsible authorities immediately on request.

REPRESENTATION TO REVIEW OF PREMISES LICENCE EVEREST CASH AND CARRY, 82-84 COVE ROAD, FARNBOROUGH GU14 0EU

My name is Aimee Vosser and I am employed as a licensing officer for Rushmoor Borough Council. I have been employed in this capacity for 6 years. I hold a BIIAB Level 2 Award for Licensing Practioners (Alcohol) and a BIIAB Level 2 Award for Licensing Practitioners (Gambling).

I am making this representation in the capacity of a responsible authority as defined in Section 13(4) of The Licensing Act 2003 and in accordance with the procedure for review of a premises licence detailed in Section 51 of The Licensing Act 2003.

In respect of the above named premises, it is my opinion that steps are necessary to promote the licensing objectives prevention of crime and disorder and the protection of children from harm.

On the 8th February 2017, Hampshire Constabulary carried out a test purchase operation with the support of the licensing team. The premises failed the test purchase by selling alcohol to a person under the legal age. By way of assisting with compliance, the seller took the opportunity of training offered by the licensing team at Rushmoor Borough Council

On the 9th February 2017, contact was made with the designated premises supervisor, Mr Rabindra Shrestha who was not aware of the failed test purchase. The licensing officer offered further training to all staff members. Mr Shrestha did not take up this offer.

On the 16th February 2017, a joint visit was carried out with Trading Standards. A plan for compliance was left with the staff member present at the time. Mrs Pun, the seller of the test purchase who agreed to put the 'Challenge 25' posters on display.

On the 28th April 2017, Hampshire Constabulary carried out a test purchase operation with the support of the licensing team. The premises failed the test purchase by selling alcohol to a person under the legal age. The ability to communicate with the seller was challenging due to the language barrier and it was

unclear whether the cashier understood that she had broken the law. By way of assisting with compliance, the seller took the opportunity of training offered by the licensing team at Rushmoor Borough Council.

In addition and as a result of the second failure, contact was made with one of the directors and designated premises supervisor of the premises Mr Rabindra Shrestha to discuss concerns over the recent test purchase failures.

On the 28th June 2017, as a result of this contact a minor variation application was made by Mr Shrestha on advice from the licensing authority to add conditions concerning 'Challenge 25' and training in order to promote the licensing objectives. As it was felt that these were the appropriate steps that if complied with would ensure no further under age sales took place. In order to assist the licence holder and designated premises supervisor, the licensing authority also provided 'Challenge 25' posters in Nepalese to display in the premises given that the customers and staff are predominately Nepalese.

On the 23rd August 2017, Trading Standards carried out a test purchase operation. The premises failed the test purchase by selling alcohol to a person under the legal age.

On the 21st September 2017, licensing officers visited the premises following the failed test purchase on the 23rd August. The staff member working at the premises was not aware of any conditions on the premises licence and she confirmed that she had had no training in relation to the sale of alcohol.

Licensing officers asked to see the training records, and these showed that no training had been carried out since 2016. Despite certificates being provided to both staff members who had attended training at Rushmoor Borough Council. No refresher training had been carried out for any other staff members, and we were unable to see evidence of any training for the staff member that was working on the day of our visit.

During our visit, I noted that the licence summary was not on display which is required by law. It was also noted that the alcohol was not on display in the correct place as per Annex 2 condition (2) of the premises licence;

'All age-restricted products shall be located behind, immediately adjacent to or within direct, unhindered visual sightline of the main point of sale service counter where access to such products can be adequately supervised, monitored and where necessary, controlled by staff'.

The cashier was not able to see the alcohol from the service counter, which is evident from the photos I attach at Exhibit 1. The staff member was advised to move the alcohol as per the premises licence, and a report of visit was left with the staff member, which is attached as Exhibit 2. The licence holder or the designated premises supervisor made no contact following this visit.

Upon each visit made by the licensing authority, the designated premises supervisor has not been at the premises, and there has been a different member of staff each time. The lack of continuity of staff members, along with the repeated offences and failure to rectify the breaches of licence, indicate that the premises licence holder has little regard for the law, advice given by the responsible authorities and leaves

me with no confidence in the management of the premises, or their ability to promote the licensing objectives.

Given the above, I support Trading Standards request that the licence is revoked as the responsible authorities have tried to work with and advise the premises, however they still continue to breach the legislation. Therefore, I believe there is no other option, which will ensure promotion of the licensing objectives.

Hampshire Constabulary would formally wish to support this application from trading standards in relation to Everest Cash and Carry.

Hampshire Constabulary has carried out test purchase operations on 8th February 2017 and 28th April 2017. The premises failed on both occasions, the second occasion was a 16yr old girl. The language barrier with the seller prevented any action being taken at that time as it was unclear that the seller either understood what she had done or the options available to her and clearly had no idea of the implications of her actions.

It is currently the policy to take a staged aproach with Test purchase failures, firstly offering training, then low level enforcement by Fixed penalties and finally by either prosecution or review of the licence.

Training has been offered to the venue but not taken up on the first occasion, on the second occasion it was not in the public interest and impractical to issue a fixed penalty ticket due to time and the cost of interpreters etc.

Considerable effort has gone into assisting this pemises with their obligation to support the licensing objectives and non has been taken up, a subsequent Test Purchase failure makes this a high risk premises in relation to the Protection of Children.

Hampshire Constabulary would fully support the revocation of the Premises Licence as it would appear the venue is incapable of upholding the licensing objectives.

APPENDIX G

MANDATORY CONDITIONS EVEREST CASH & CARRY, 82 - 84 COVE ROAD, FARNBOROUGH, HAMPSHIRE, GU14 0EU

Where applicable in the circumstances, one or more of the following mandatory conditions **must** be applied to a premises licence.

Section 19 – Mandatory conditions: supply of alcohol

Where a premises licence authorises the supply of alcohol -

- (1) No supply of alcohol may be made under the premises licence -
 - (i) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (ii) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The Licensing Act 2003 (Mandatory Conditions) Order 2014

- (1) (i) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (ii) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (iii) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature
- (2) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. For the purposes of this condition
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula P = D + (DxV)

Where -

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
 - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) The holder of the premises licence
 - (ii) The designated premises supervisor (if any) in respect of such a licence, or
 - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
 - (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
 - (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
 - (f) Where the permitted price given by Paragraph (b) would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
 - (g) Paragraph (b)(ii) applies where the permitted price given by Paragraph (b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (h) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
