#### FARNBOROUGH AIRPORT COMMUNITY ENVIRONMENTAL FUND

## **Summary and Recommendations:**

The Cabinet Member for Environment has considered three applications totalling £17,474 and has made two award recommendations, which Cabinet is recommended to approve.

#### 1. Introduction

1.1 This paper seeks approval to award grants from the Farnborough Airport Community Environmental Fund to assist local projects.

#### 2. Background

- 2.1 The Community Environmental Fund commenced in 2001. It is levied by Farnborough Airport on business aviation movements at a rate of £2 per aircraft movement and £5 per aircraft movement where the aircraft is a Boeing business jet or an Airbus A310 corporate jet.
- 2.2 The fund is available to groups and organisations under the following criteria:
  - Located within 5 kilometres (3 miles) from the centre of Farnborough Airport (taken to be halfway down the main runway)
  - Within this 5 kilometre radius, is demonstrably and regularly affected by aircrafts travelling to and from Farnborough Airport
  - Will result in the improvement or provision of an outdoor facility or area that is accessible to the public and able to be enjoyed by the community as a whole
  - Is a community or environment based bid, projects may include: -
    - Green or open spaces
    - Natural habitats
    - Environmental improvements or outdoor play

 Community projects with an emphasis on improving the local environment or outdoor education

## 3. Details of the Proposals

- 3.1 The Cabinet Member for Environment has considered three applications and has made award recommendations for two:
  - Farnborough Grange Nursery and Infant School £5,000

■ Southwood Infant School £7,796

Total £12,796

- 3.2 Details are outlined for each applicant in Appendix A.
- 3.3 An award was not made to 3<sup>rd</sup> Farnborough Scout Group as the project to provide fencing and cut back trees does not meet the criteria of the fund. The group have been directed to other funders.

#### 4. Financial and Resource Implications

4.1 The Community Environmental Fund is currently £63,671. Taking the two applications recommended in this paper totalling £12,796 would leave £50,875 available for allocation.

5.1 Cabinet is recommended to approve the awards totalling £12,796

Additional Information	The worn matting will be replaced with a bonded rubber mulch safety surface made from recycled forklift truck tyres. It is installed to create a seamless playground floor with no loose particles, enabling safe, outdoor play all year round.  By replacing the worn matting with an all-weather area around the existing trim trail, the 130 children at the school and a further 20 who attend the afterschool/holiday club will be able to increase their daily activity levels, motor skills and coordination. It will also help them to stay fit and healthy and to build relationships.  The trim trail is not currently in use as the surface is perishing and is uneven due to drainage run off problems.
