#### DETERMINATION OF AN APPLICATION FOR VARIATION OF A PREMISES LICENCE

### THE FUNKY END, STATION ROAD, ALDERSHOT GU11 1HT

#### 1.0 INTRODUCTION

- 1.1. This report concerns an application to vary a premises licence made under section 34 of the Licensing Act 2003 (the 'Act'). Representations have been received in respect of the application and invoke a statutory requirement to hold a hearing with members.
- 1.2. The report provides details of, and background to the application, and should be read in conjunction with the Council's licensing policy and Secretary of State's guidance. This, together with information obtained at the hearing should be used to determine the application.

#### 2.0 BACKGROUND

- 2.1. An application for variation of an existing premises licence was submitted on 8<sup>th</sup> September 2016 by Punch Taverns PLC, in respect of the premises.
- 2.2. A map of the area showing the general location of the premises is given at **appendix A**.

#### 2.3. Existing premises licence

- 2.4. The application requests the variation of the existing premises licence 16/00234/LAPRER, varied on 17<sup>th</sup> May 2016. The original premises licence was granted on the 24<sup>th</sup> November 2005.
- 2.5 The current licence was subject to a review on the 17<sup>th</sup> May 2016, which resulted in a reduction in hours for licensable activities and some additional conditions.
- 2.6. A copy of the premises licence is given as **appendix B**.

#### 2.7. Nature of the application

2.8. The application seeks to amend the permitted hours for all licensable activities on Thursday's to Saturdays to 11:00am – 02:00am. The application also seeks to amend conditions on the premises licence.

2.9. A copy of the application form is given at **appendix C**.

## 2.10. Advertising of the application

2.11.1 can confirm that each responsible authority (as specified in the Act) has received a copy of the application. I can also confirm that the application was advertised by the applicant in accordance with the requirements of the legislation both at the premises and in a suitable newspaper. The last date for representations was given as the 6<sup>th</sup> October 2016.

### 3.0 APPLICATION AMENDMENTS

### 3.1. Hampshire Constabulary

3.2. The applicant has agreed to a number of amendments to the operating schedule of the application in the form of conditions. These changes were made in negotiation with Hampshire Constabulary and are set out in the correspondence given at **appendix D**.

## 4.0 OTHER PERSON REPRESENTATION

- 4.1. One representation by way of an objection and seven representations by way of support were received in respect of the application as outlined below.
- 4.2. A copy of the representations are given at **appendix E.** For ease of reference the representations have been marked E1 to E8.

### 4.3. Relevance of Representation(s)

- 4.4. To be eligible to be considered, the Act requires a(ny) representation(s) to be *'relevant'*. A *'relevant representation'* is one that has been made by a responsible authority or any other person within the prescribed period permitted. Similarly, representations must not be frivolous or vexatious and must be about the likely effect of the grant of the licence on the promotion of the licensing objectives.
- 4.5. The licensing objectives are defined in the Act and include -
  - (a) the prevention of crime and disorder;
  - (b) ensuring public safety;
  - (c) the prevention of public nuisance; and
  - (d) the protection of children from harm.

### 4.6. Relevance of representations

4.7. Against the above criteria the representations are considered to be relevant as they were submitted within the prescribed period and concern two of the licensing objectives; namely the prevention of crime and disorder and public nuisance.

## 5.0 DATA PROTECTION ISSUES

5.1. As a public document, any personal details, including addresses, contact details and/or signatures submitted on any application, representation or other document contained in this report have been redacted in accordance with data protection requirements.

### 6.0 DETERMINATION

6.1. Further to the receipt of relevant representations and, in accordance with the Act and the Council's scheme of delegation, the Sub-Committee is asked to determine the application.

## 7.0 RELEVANT CONSIDERATIONS

### 7.1. Licensing Objectives

7.2. In determination of the application, the licensing authority must have regard to the promotion of the licensing objectives. These are set out at paragraph 4.8 above.

### 7.3. Licensing policy & S182 Guidance

7.4. The licensing authority must also have regard to its statement of licensing policy and any guidance issued by the Secretary of State under section 182 of the Act. Details of the parts of the policy and guidance that may be relevant to this application are given in **appendix F** to this report.

### 8.0 OPTIONS

- 8.1. In determining this application, the Sub-Committee may take any of the following steps as it considers appropriate for the promotion of the licensing objectives; namely -
  - (a) to vary the licence as applied for\*; or
  - (b) to modify the conditions of the licence, or
  - (c) to reject the whole or part of the application.
  - \* Subject to any relevant mandatory conditions (as shown on Annex 1 of the premises licence), amendments agreed by the applicant and/or such other conditions that are consistent with the operating schedule which, with the exception of mandatory conditions, may be modified<sup>†</sup> to such extent as may be appropriate to promote the licensing objectives.
  - <sup>*†*</sup> Modifications may include the alteration or omission of a condition or the addition of any new condition(s).

## 9.0 RECOMMENDATION(S)

- 9.1. The Sub-Committee is asked to determine the application having regard to -
  - (a) the contents of this report;
  - (b) any additional information obtained from the hearing;
  - (c) the Council's licensing policy;
  - (d) guidance issued by the Secretary of State; and
  - (e) the promotion of the licensing objectives.



#### Annex 1 – Mandatory conditions

- (1) No supply of alcohol may be made under the premises licence:-
  - (i) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (ii) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (3) (i) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (ii) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (iii) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- (4) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. For the purposes of this condition –
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
  - (b) "permitted price" is the price found by applying the formula -

P = D + (DxV)

Where –

- (i) P is the permitted price
- D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

- V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
  - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence –
    - (i) The holder of the premises licence
    - (ii) The designated premises supervisor (if any) in respect of such a licence, or
    - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
  - (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
  - (f) Where the permitted price given by Paragraph (b) would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
  - (g) Paragraph (b)(ii) applies where the permitted price given by Paragraph (b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (h) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- (5) (i) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities,

carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- (6) The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (7) The responsible person must ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- (8) Where, at any specified time(s), one or more individuals must be at the premises to carry out a security activity (within the meaning of the Private Security Industry Act 2001), each individual must be licensed by the Security Industry Authority (SIA).

#### Annex 2 – Conditions consistent with the Operating Schedule

- (1) No licensable activities shall be undertaken except during permitted hours.
- (2) The above restriction does not prohibit:-
  - during the first thirty minutes after the permitted hours, the consumption of alcohol on the premises;
  - (ii) the taking of alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
  - (iii) during the first thirty minutes after the permitted hours the consumption of alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;
  - (iv) the consumption of alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
  - (v) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
  - (vi) the sale of alcohol to a trader or club for the purposes of the trade or club;
  - (vii) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
  - (viii) the taking of alcohol from the premises by a person residing there;
  - (ix) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
  - (x) the supply of alcohol for consumption on the premises to persons employed there for the purpose of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of the employer or of the person carrying on or in charge of the business on the premises.
- (3) The premises shall remain open for 30 minutes following the last sale of alcohol during permitted hours. This period may be used for drinkingup and the use of lavatories only.

- (4) No children shall be allowed on the premises at any time unless accompanied by an adult
- (5) (i) Exits or escape routes from the premises are to be maintained clear of any objects that may impair the ability of persons to use said exits or escape routes at all times.
  - (ii) All exits and escape routes shall be clearly marked by suitable and sufficient signage in accordance with the attached plan(s).
  - (iii) A suitable and sufficient evacuation policy shall be developed and maintained for the premises and implemented as may be appropriate in the event of emergency.
- (6) (i) A suitable, sufficient and well-maintained emergency lighting and fire alarm system shall be maintained at the premises in accordance with the attached plan(s).
  - (ii) Suitable and sufficient fire extinguishers shall be maintained at the premises in accordance with the attached plan(s). All such equipment must be regularly serviced and maintained in such condition that it may be effectively used at all times.
- (7) The rear courtyard area of the premises shall be served by suitable and sufficient lighting when used in hours of darkness.
- (8) Suitable and sufficient supplies of first aid equipment / materials must also be made available to members of the public on request. Dependant on the activities, events and risks at the premises, a suitably trained first aider or an appointed person for first aid must also be present on the premises at all times during licensable activities.
- (9) Prominent, clear and legible notices shall be located at all exits of the licensed premises requesting patrons and staff to leave the premises and area quietly.
- (10) By way of preventing public nuisance, the main entrance to the front aspect of the premises shall be served by a suitable lobby that ensures, so far as is reasonably practicable, the main entrance to the premises is closed and kept closed at all times, save for access and egress thereof.

#### Annex 3 – Conditions attached after a hearing by the licensing authority

- (i) All external doors and the front internal lobby doors shall be kept closed, other than during access and egress from 21.00 hrs until the end of specified opening hours on any day.
  - (ii) All external doors and front internal lobby doors shall be fitted with self-closing devices.
  - (iii) All external windows shall be kept closed from 21.00 hrs until the end of specified opening hours on any day.
- (2) (i) All sound amplification systems shall be played through a suitable sound-limiting device.
  - (ii) The sound level from this device shall be set at a level agreed with Environmental Health Services at Rushmoor Borough Council and shall be secured from adjustment thereafter.
  - (iii) Any change to this sound level shall be agreed in advance with Environmental Health Services on giving at least five working days notice.
- (3) (i) Notwithstanding the requirements above, the licence holder or nominated representative(s) shall carry out a regular noise assessment of the area adjacent to the premises whilst licensable activities are taking place.
  - (ii) Noise assessments shall take place on all sides of the premises at the boundary of the nearest residential premises. Steps shall be taken to reduce the level of the noise where it is likely to cause a nuisance to local residents.
  - (iii) These assessments shall be undertaken at hourly intervals starting from 22:30pm.
  - (iv) Written records of these assessments and any remedial action taken should be kept and made available to either the local authority or the Licensing Authority when requested.
- (4) (i) A suitable written policy on the dispersal of patrons leaving the premises shall be developed for the premises. This policy shall be actively implemented and enforced at the premises and shall be reviewed, revised and updated as often as may be necessary.
  - (ii) All staff and door supervisors will be required to read and sign a copy of the policy as part of their training and to assist in its enforcement as necessary.

- (iii) This policy will be made available to police and licencing officers on request.
- (5) Suitable written records of any complaints about the premises, its customers, staff and/or the activities carried on there must be kept and made available to officers of Rushmoor Borough Council on request. These records should include, but not be limited to, the nature of any complaint(s), action(s) taken in response, the date(s) and time(s) when any complaint was made, together with the name of the person(s) who handled the complaint.
- (6) With the exception of bona fide employees and staff, no individuals shall be permitted to enter or re-enter the premises at any time between 00.00midnight and the end of specified opening hours on a Thursday, Friday or Saturday.
- (7) Local residents, particularly those inhabiting Ascot Court and Kingsley Court, shall be provided with a direct number to contact the premises should they wish to make complaint.
- (8) (i) On any day where the premises is open past midnight, from 21.00 hrs, only drinking vessels made from polycarbonate or plastic may be used to serve drinks to customers at the premises. No drinks are to be served to customers in glass bottles. In every case, they will be poured into appropriate vessels by the bar staff.
  - (ii) Any drinks which have already been served to patrons in a glass vessel shall be dispensed into a polycarbonate or plastic vessel.
- (9) No amplification equipment shall be used on live or recorded music playing in the rear back room of the premises.
- (10) Suitable and sufficient signage shall be displayed in the rear external drinking area asking patrons to be mindful and considerate of neighbours of the premises and to use the premises quietly after 23.00 hrs.







I visit the pub for the quiz night on Wednesday's and sometimes on a Friday evening, Saturday or Sunday lunch time and at these times it is often very quiet. In these days when public houses are closing due to poor takings and lack of customers it seems a shame to limit this and any other public houses ability to make money when they can. This pub is a meeting place for locals ,organises charity events, showcases top entertainment acts and is a big part of the local community, by allowing them to remain open later they will be able to compete with other clubs and pubs in the area and increase their profits for times when they are less busy. The Funky End also employs many wonderful staff, without the late opening their jobs would be at risk.

My only concern is to some of the restrictions that they have had placed upon them with the new licence, e.g. the use of plastic drinking vessel after 9pm, and that drinks must be decanted into these vessels.
